



Dear Mr. Bohlen,

On behalf of Sea Meadow Marine, I am writing to express our sincere appreciation for the grant award of \$5000.00 from the Bonnell Cove Foundation. As you know, Sea Meadow Marine is a volunteer 501(c)(3) non-profit whose mission is to provide affordable access to, and protection of the working waterfront for those who make their living from the sea.

As stated in our application, these funds will be used to continue the development of the Collab partner support program as we move beyond the water access step to help new aquaculture farmers by providing equipment and programmatic support.

During the past year we made progress in other key areas. We are in the final due diligence stages of the Land for Maine's Future - Working Waterfront Access Protection Program; once completed the boatyard will be protected permanently as working waterfront. We recently completed repair of the wharf/bulkhead, which will serve our customers for years to come and we hope to install sewer and water utilities within the next year. Our student programs are also generating educational opportunities and innovative, sustainable solutions in support of the "Blue Economy" in our coastal communities.

We believe our project represents a platform to share our mission and become a model for other communities in jeopardy of losing similar spaces.

We are grateful for this grant from the Bonnell Cove Foundation.
